| Are there services covered before you meet your deductible? | Yes. Preventive care , office visits, chiropractic care & prescription drugs are covered before you meet your deductible . | This plan covers some items and services even if you haven't yet met the deductible amount. Your Grievance and Appeals Rights: There are agencies that can help if you have a complaint against your plan for a denial of a claim. This complaint is called a grievance or appeal. Does this plan provide Minimum Essential Coverage? Yes
